INVITATION TO BID

31. The Municipality of Alfonso Lista, Ifugao through the Bids and Awards Committee (BAC) intends to apply the sum of **Php 10,838,655.00** being the Approved Budget for the Contract (ABC) to payments under the contract for the ***"Improvement/ Expansion of Level III Water System in Brgy. Sto. Domingo, Brgy. Busilac, Brgy. Pinto, and Brgy. Kiling.*** Bids received in excess of the ABC shall be automatically rejected at bid opening.
32. The Municipality of Alfonso Lista, Ifugao now invites bids for the Improvement/ Expansion of Level III Water System in Brgy. Sto. Domingo, Brgy. Bisilac, Brgy. Pinto and Brgy. Kiling, Alfonso Lista, Ifugao. Completion of the Works required thirty one days (301) C.D. Bidders should have at least completed a single contract that is similar to the Project and equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
33. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
64. Interested bidders may obtain further information from the **LGU-BAC Secretariat, Bids and Awards Committee Office** and inspect the Bidding Documents at the address given below starting September 25, 2020 from 8:00 A.M. to 5:00 P.M. (***Invitation/Issuance of Bidding Documents***).
65. A complete set of Bidding Documents may be purchased by interested Bidders from the **LGU-Bids and Awards Committee- BAC Secretariat** in the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Php 25,000,000.00**.
66. The Municipality of Alfonso Lista, Ifugao, through the Bids and Awards Committee will hold a **Pre-Bid Conference** on October 5, 2020 at 9:00 a.m at the **Bids and Awards Committee Office**, which shall be open to all interested parties who wish to attend the Pre-Bid Conference.

67. Bids must be submitted/delivered/dropped on or before **October 19, 2020** at **9:00 a.m.** at the Bids and Awards Committee Office located at **Executive Building, Sta. Maria, Alfonso Lista, Ifugao**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause of the Bidding Documents.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. **Bid opening on October 19, 2020 at 10:00 a.m.** Late bids shall not be accepted.
